STEP-BY-STEP CHECKLIST FOR OBTAINING GUARDIANSHIP OF A MINOR

You have decided whether your Guardianship is **"Special"** (emergency and expires in 30 days) and/or **"General"**. Either way, you will need to schedule a hearing with a Judge and let the others involved in the Ward's life know that you are applying for a Guardianship.

The key to being successful with this process is organization, as it involves a lot of paperwork. Keeping your paperwork organized will help the process seem less overwhelming. Take the process one step at a time. Take your time and complete each task before moving on to the next one.

It is recommended that you use file folders to organize all the paperwork, and that you label the three folders as follows:

Folder #1: Take to courthouse to file Folder #2: Take to have notarized/make copies Folder #3: Important Documents to Keep

These are instructions for a regular guardianship and do NOT fully cover the steps for obtaining guardianship of a minor in the following situation:

- If the child is 14 years old or older;
- If this is an emergency where a child needs to be protected from physical or financial harm;
- If you are unable to pay court fees;
- If the child is enrolled or eligible for enrollment in a Native American Indian tribe;
- If OKLAHOMA DHS is involved;
- If the guardianship is or will be contested.

If your case involves any of the above factors, **special instructions may apply which are not a part of this guide**. Please seek advice from a qualified attorney.

BACKGROUND CHECKS WILL BE REQUIRED FOR THE PERSON(S) SEEKING GUARDIANSHIP AND ANY PERSON OVER THE AGE OF 18 WHO IS OR WILL BE LIVING IN THE SAME HOME AS THE MINOR CHILD. It is strongly encouraged that you begin the background check process immediately upon filing your Petition for Guardianship as the process can take a long time and you will have to keep returning to court until the background check results are complete and provided to the Court. Instructions for obtaining the required background checks are included later in this guide.

□ **STEP 1-** Find the form PETITION FOR LETTERS OF GUARDIANSHIP (MINOR)

-You are the petitioner and the child is the ward

-Don't sign it yet. You will sign in front of a notary and have your signature notarized. -Put the completed form in the **folder #2** named "Take to have notarized/make copies".

□ **STEP 2**- Find the form <u>OKLAHOMA SEX OFFENDERS REGISTRATION ACT-</u> <u>AFFIDAVIT (EXHIBIT A)</u>

-Put the child's name on the top where it says: In the matter of the Guardianship of

-Don't sign it yet. You will sign in front of a notary and have your signature notarized. -Put the form in **folder #2** named "Take to have notarized/make copies"

□ **STEP 3-** Find the form <u>UNIFORM CHILD CUSTODY JURISDICTION AND</u> ENFORCEMENT ACT AFFIDAVIT (EXHIBIT B)

-Enter your name as Petitioner

-Fill in the rest of the blanks

-Don't sign it yet. You will sign in front of a notary and have your signature notarized. -Put the form in **folder #2** named "Take to have notarized/make copies.

□ **STEP 4**-Find the form <u>PLAN FOR THE CARE AND TREATMENT OF THE WARD(S)</u> -Fill in the form.

-It is okay to sign it now.

-Put form in **folder #2**

□ **STEP 5**- Find the form <u>PLAN FOR THE MANAGEMENT OF THE PROPERTY OF THE</u> <u>WARD(S)</u>

-Fill in the form

-If the child does not have any property, just say so.

-Put the form in **folder #2**

□ STEP 6-Take the documents in folder #2 to a notary (a notary can be found at your local post office, tag agency, or bank, and your local courthouse law library may also have a notary) -Sign in front of the notary and have Notary sign and notarize:

 <u>PETITION FOR LETTERS OF GUARDIANSHIP</u>
 OKLAHOMA SEX OFFENDER REGISTRATION <u>ACT AFFIDAVIT (EXHIBIT A)</u>
 UNIFORM CHILD CUSTODY JURISDICTION AND ENFORCEMENT ACT AFFIDAVIT (EXHIBIT B)

-Put all notarized documents back into folder #2.

-Take note that these documents are the originals. POINTER: Unless the Notary signs in blue ink or uses a blue, red, or green notarial stamp, you may want to make a PENCIL mark at the bottom of these documents to indicate that they are originals.

□ **STEP 7-** Take the original documents in **folder #2** to where you can make copies.

-Determine how many copies you will need:

-Put all originals and copies in folder #1 named Take to Courthouse to file.

□ STEP 8-Prepare for your first trip to the county courthouse

-You will need to file the Guardianship Petition in one of the following counties:

- The County in which the child resides;
- The County in which you live if you are a member of the child's family;

-There is a filing fee to file the Guardianship Petition. You will need to bring cash or a personal check with you when you file the Petition. There are some circumstances when the filing fee may be waived, see below:

*The court filing fee MAY be waived if you have no money (file a PAUPER'S AFFIDAVIT), if the child is receiving TANIF, SoonerCare, or social security benefits, or if you are a relative of the child and the child's natural parents have abandoned the child.

-Take all the documents in **folder #1** with you to the appropriate county courthouse. -Put the following documents into **folder #2**: <u>ORDER FOR HEARING PETITION FOR</u> <u>GUARDIANSHIP OF MINOR CHILD(REN)</u>, NOTICE OF HEARING PETITION FOR <u>GUARDIANSHIP OF MINOR CHILD(REN)</u>, AFFIDAVIT OF SERVICE. Take these with you to the courthouse.

- □ A. Find the Cashier window in the Court Clerk's office. (Depending on the County in which you are filing your case and the size of the courthouse, there may not be a separate cashier's office, and the court clerk may be able to handle your case filing and payment.)
 - 1. Hand the cashier the original <u>PETITION</u> and ask to file a new guardianship case for a minor child.
 - 2. You will be assigned a Judge and given a case number.
 - 3. You will pay the required court filing fee, unless waived for any of the reasons addressed above.
 - 4. Put the case number on each copy of the <u>PETITION</u>.
- \Box B. Find a court clerk in the clerk's office who is free to help you.
 - 1. Hand the clerk the original <u>PETITION</u> with <u>Exhibit A</u> and <u>Exhibit B</u> attached, **PLUS**:
 - 2. Hand the copies of the <u>PETITION</u> to the court clerk.
 - 3. The court clerk will file stamp the original and all copies. The clerk will keep the original and return the copies to you.

□ **STEP 9-** Schedule the Court Hearing on the Guardianship

-Find the name of the Judge who is assigned to your case. Look up their name on the courthouse directory to find the Judge's office.

-Go to the Judge's office. The Judge's assistant will help you. Tell the assistant that you need to schedule a minor guardianship hearing and hand the assistant a copy of the file-stamped <u>PETITION</u>.

-Schedule the hearing at least 2 weeks from the day you contact the Judge's assistant. You will need to allow time to mail notices to the appropriate persons at least ten (10) days prior to the hearing date.

-Write down the date and time of the hearing on the Order for Hearing and Notice of Hearing

□ **STEP 10-** Find the form <u>ORDER FOR HEARING PETITION FOR GUARDIANSHIP OF</u> <u>MINOR</u> in **folder #1**.

-Fill out the information

-Make one copy of the original.

-Hand the original and the copy to the Court Clerk

-The Clerk will stamp the Judge's name and file stamp both the original and copy. You will get the copy back and the clerk will keep the original.

-Put the copy in **folder #2**.

□ STEP 11- Find the form <u>NOTICE OF HEARING PETITION FOR GUARDIANSHIP OF</u> <u>MINOR CHILD</u>

- -Fill in the date and time of the hearing you scheduled.
- -Make at least one copy of the original.
- -Hand the original and the copy to the Court Clerk
- -The Clerk will stamp the Judge's name and file stamp both the original and copy. You will get the copy back and the clerk will keep the original.
- -Put the copy in **folder #2**.
- □ STEP 12-Prepare for mailing copies of the <u>PETITION</u>, copies of the <u>ORDER</u> and <u>NOTICE</u> <u>OF HEARING</u> (contents of **folder #2**) to make copies and get notarized.

-You are required by law to notify all persons who claim any right to child by mailing them copies of the <u>PETITION</u>, <u>ORDER</u>, and <u>NOTICE OF HEARING</u>.

- -Keep a list of the name and addresses of everyone entitled to notice about the guardianship- every person you listed as needing copies of the <u>PETITION</u> (on page 3).
- -Make enough copies of the <u>ORDER</u> and <u>NOTICE</u> so that each person on your list gets one.
- -You will need business size envelopes. Put the name and address of on each envelope and add stamp.
- -Put the addressed, stamped envelopes with the copies of the <u>PETITION</u>, <u>ORDER</u>, and <u>NOTICE</u> of the hearing in the mail.
- -Find the form <u>AFFIDAVIT OF SERVICE</u>
- -Fill in the names of everyone you sent documents to.
- -Sign in front of notary and have your signature notarized.
- -Make a copy and put original and copy in folder #1.
- □ STEP 13: Prepare to go to courthouse to file documents prior to hearing.

-Folder #1 should contain the notarized <u>AFFIDAVIT</u> plus at least one copy, the <u>PLAN</u> <u>FOR THE CARE AND TREATMENT OF THE WARD</u> plus at least one copy, and the <u>MANAGEMENT OF THE PROPERTY OF THE WARD</u> plus at least one copy.

-Take to the Court Clerk's office.

-Find a clerk who is free to help you.

-Hand the clerk both the original and the copy of each document.

-The clerk will file stamp both documents, keep the original and hand you back the file-stamped copy.

-Put all file-stamped copies in folder #3.

□ STEP 14- BACKGROUND CHECKS

The State wants to be sure that your home is safe for a child. To do this, you must follow the steps below to have the necessary background checks done for yourself and each person over the age of 18 who lives in the home with the child for whom you seek guardianship. The State will want checks from different agencies. You must provide the completed background check results to the Court. Please refer to the last three (3) pages of this checklist for a "GUIDE TO OBTAINING"

REQUIRED BACKGROUND CHECKS FOR GUARDIANSHIP OF A MINOR", and follow the steps there.

□ **STEP 15**-Prepare to attend the hearing

-Put the following documents in **folder #1**:

- ORDER APPOINTING GUARDIAN OF MINOR CHILD(REN)
- <u>LETTERS OF GUARDIANSHIP</u>
- ORDER APPROVING PLAN

-Attend the hearing. Give the documents in **folder #1** to the Judge to review and sign.

□ **STEP 16**-Make **5** copies of each document the Judge signed.

-Hand the originals and copies to the clerk. Ask the court clerk to file the <u>Orders</u> and <u>Letters</u> signed by the Judge and get certified copies.

GUIDE TO OBTAINING REQUIRED BACKGROUND CHECKS FOR GUARDIANSHIP OF A MINOR

Pursuant to 30 O.S. § 2-101, you must complete the following background checks prior to obtaining guardianship of a minor child. NOTE: The Court may grant emergency guardianship pending completion of these requirements, but in order to obtain ongoing guardianship, you must fulfill these requirements as to the prospective guardian(s) and **all** other household members eighteen (18) years of age and older.

In the case of an <u>emergency placement</u>, the court may waive the requirement for a CANIS search if it cannot be obtained in a reasonable time and the court determines that it is in the minor's best interest that the CANIS search be waived. (30 O.S. Supp. 2020, § 2-101(C)(4).)

If the CANIS requirement is waived on an emergency basis, the court may still require a CANIS search to be completed before granting general guardianship.

You must complete one of the options in Step 1, AND Steps 2 and 3 completely.

□ STEP 1: A review of a national fingerprint-based criminal background check; <u>or</u> an Oklahoma State Bureau of Investigation ("OSBI") name-based criminal history background check and Sex Offender Registry Check.

HOW TO COMPLETE STEP 1:

STEP 1, OPTION 1:

Complete the OKLAHOMA STATE BUREAU OF INVESTIGATION - Criminal History Record Information Request form included here for **ALL** guardians, co-guardians, and any person living in your home who is eighteen (18) years of age or older. You should select"Name Based" and "Sex Offender" in the "Type of Search Requested" box. Where it asks the purpose of your request, choose "Personal Review".

You must complete a separate form for each person. You must pay a separate fee for each request. Each search with these selections should cost \$17.00.

The simplest, quickest way to fulfill this requirement is to submit an online request for name-based and sex offender registry check through the OSBI. You can visit <u>https://chirp.osbi.ok.gov/</u> for information on how to complete and submit this request.

Another option is to mail or deliver in-person the completed form, with payment, to OSBI – Criminal History Record Information Request, 6600 North Harvey Place, Oklahoma City, OK 73116. If you submit the form by mail, you must include a return envelope, with your address and postage prepaid on the envelope so the results will be mailed back to you.

You can also fax the form to 405-879-2503. If you submit the form by fax, you must be able to receive your results by return fax and you MUST include credit card payment information on the form.

If you choose Option 1 for Step 1 and select "Name Based" **and** "Sex Offender" in the "Type of Search Requested" box, this will fulfill the requirements of Step 1 and Step 2. (Step 2 is outlined on the next page.) You do not need the OSBI name-based *and* sex offender search *and the FBI search; you may choose one or the other*.

Form for Step 1, Option 1: OKLAHOMA STATE BUREAU OF INVESTIGATION Criminal History Record Information Request (Attached)

STEP 1, OPTION 2:

You can visit <u>https://www.fbi.gov/services/cjis/identity-history-summary-checks</u> for information on how to complete an **Identity History Summary Checks** online, through the Federal Bureau of Investigation (FBI). This is a "national fingerprint-based criminal background check," as described in the laws related to guardianships of minor children.

If you choose Option 2, you will also need to complete Step 2, outlined on the next page.

□ STEP 2: A search of the Department of Corrections' files maintained pursuant to the Sex Offenders Registration Act.

HOW TO COMPLETE STEP 2:

Complete this requirement by checking "Sex Offender" in the "Type of Search Requested" box on the OKLAHOMA STATE BUREAU OF INVESTIGATION - Criminal History Record Information Request completed in *Step 1*, *Option 1*. This will add \$2 to the fee for submitting this form (for a total of \$17.00 as noted above).

If you completed an Identity History Summary Checks through the Federal Bureau of Investigation (FBI) website (Step 1, Option 2) then you can fulfill Step 3 by completing the form **OKLAHOMA STATE BUREAU OF INVESTIGATION - Criminal History Record Information Request** form included here. You will only need to select "Sex Offender" in the "Type of Search Requested" box. Where it asks the purpose of your request, choose "Personal Review".

The results will be mailed directly to you. Upon receipt, you will need to submit the full and complete results to the Court by filing the original with the Court Clerk in the county where you filed your guardianship request.

□ STEP 3: Search of the child abuse and neglect information system maintained for review by authorized entities by the Department of Human Services (also known as a "DSH CANIS search").

HOW TO COMPLETE STEP 3:

Complete the **Request for Child Abuse and Neglect Information System (CANIS) for Guardianship** form included here. Turn-in the completed form **AND a copy of your filestamped, certified Petition** (the documents you filed to request the Court grant your guardianship). If you have a hearing upcoming, it is a good idea to note that in your completed request. You can list all adults in your household on one form. The results of your request will go directly to the Judge you list as hearing your case. **This request can take a few weeks to a few months to complete.**

You can submit the form for Step 3 in one of three ways:

- 1. By <u>emailing</u> the completed form AND your file-stamped Petition to <u>canisguardianship@okdhs.org;</u>
- 2. By <u>faxing</u> the completed form AND your file-stamped Petition to fax # 405-521-4373;
- By <u>mailing</u> the completed form AND your file-stamped Petition to: Oklahoma Department of Human Services Child Welfare Services Child Abuse and Neglect Information System PO Box 25352 Oklahoma City, OK 73125

DHS may charge a fee, but not more than Thirty-five Dollars (\$35.00) for each search.
