RE: Scheduling Video Visitation

I am seeking your assistance in sending this document out to all associated attorneys registered with the Oklahoma Bar Association.

As you are aware, we have closed access to the jail as a method to protect the citizens of Tulsa County due to the COVID-19 outbreak. As a means to retain access with your client, we have provided at no cost, video visitation using the JailATM.com website. As with any new undertaking, you learn and better the process as we move forward. Below we will provide your members instructions on how to allow us to better serve them.

In an effort to facilitate these visits more efficiently, we ask all attorneys, especially those seeing several clients, to email a list including inmate names and times you'd like to visit to Corporal Brown at <a href="mailto:mbrown@tcso.org">mbrown@tcso.org</a>. This will allow us to have inmates available at scheduled times and reduce the number of unanswered video calls where your client doesn't answer. This will also allow pod officers time to prepare and work out any technical difficulties in advance as well as reserve kiosks for professional visits as they will take precedence over social visits. Emails must be received by 2:00 p.m. the day before your intended visit, this will allow us to complete all scheduling requirements.

Visits can be scheduled every 20 minutes. It will be up to you to estimate how much time you'll need between each visit. Visits may be scheduled for any day of the week. Available times are:




