MODIFIED TEMPORARY EMERGENCY ORDER

The Temporary Emergency Order No. AO-20-16, dated November 25, 2020, is amended and modified. In consideration of the Fourth Emergency Joint Order, 2020 OK 96 as issued jointly by the Oklahoma Supreme Court and the Oklahoma Criminal Court of Appeals, the continued rise in COVID-19 cases, and the predicted rise of infections, the Creek County Courthouse offices of the Court Clerk, judge's offices, and courtrooms, including the Bristow Division, are closed to all in-person proceedings effective with the date of this Order through January 8, 2021, except for emergency matters or matters held with the assigned judge's permission.

All judges may continue to conduct as many matters as possible by telephone or virtual hearings. All suspended cases originally set for November 30, 2020, through January 8, 2021, are hereby reset exactly 6 weeks later on the same day of the week at the same time as the original setting, with the following exceptions: if the new date falls on January 18, which is a Federal holiday, then the matter is reset for January 25. If the new date falls on February 15, which is also a Federal holiday, it is reset for February 22. The dates and times of cases set on the suspended dockets may be individually reset by specific order of the assigned judge.

The revised schedule is as follows:

Cases originally set the week of November 30 are reset for the week of January 11.

Cases originally set the week of December 7 are reset for the week of January 18, with the exception above as to the Federal holiday on January 18.

Cases originally set the week of December 14 are reset for the week of January 25.

Cases originally set the week of December 21 are reset for the week of February 1.

Cases originally set the week of December 28 are reset for the week of February 8.

Cases originally set the week of January 4 are reset for the week of February 15, with the exception above as to the Federal holiday on February 15.
