- Enrollment in ABA accredited law school
- Law School Certification/Recommendation letter verifying the requirements below. Your law school will submit.
 - Completion of half of the courses required toward Juris Doctor
 - o Completion of Professional Responsibility, Evidence and Civil Procedure I & II, or equivalent
 - Graduating GPA.
- Passing score on LLI Exam-Part A and B
 - A passing score on the Multistate Professional Responsibility Examination (MPRE) will exempt the applicant from Part B of the exam. The applicant must submit a copy of the MPRE exam score to receive exemption.
- A completed and approved Law Student Registration through the Oklahoma Board of Bar Examiners to meet character and fitness requirements. This process may take 6 months to complete.
 - Character and fitness may be completed through another state. The applicant must submit documentation showing the standards are equivalent to those in Oklahoma. The Legal Internship Committee determines if the standard has been met.
- Approved supervising attorney, Form 2.

I understand if my Legal Intern License is terminated due to my failure of the bar examination or other change in status, my supervising attorney will be notified by the Oklahoma Bar Association.
